Abstract of Agreement of HUFUCTO with the Haryana Govt. on 17.05.2011 followed by four rounds of discussions regarding distortions in UGC recommendations by Haryana Govt Notification dated 29-04-2011

1.	For the post of Professor (Direct)-10 year Exp/10 publications in the form of book is mentioned instead of UGC recommended books/ research paper etc. Page no. 4 (Hry), clause 4.2 (1) – UGC Pages 5.	As per UGC but with publication of research papers in referred Journals
2.	Post of professor in colleges is not mentioned, while in UGC notification it is clearly mentioned. According to UGC notification there shall be one post of professor in each department of a PG College, but it is deleted in Haryana Govt. notification. UGC Clause no.6.5.1, 6.5.2/ Haryana Not Accepting It.	Accepted to constitute a committee involving representatives from HFUCTO
3.	Instead of 5 increments of Ph.D at entry level of a newly appointed teacher, only 4 increments are given only to those candidates, who have NET with Ph.D along with the condition on Notional basis from 1.1.2006 and actual from 29-4-2011. It is clearly a violation of UGC regulations. Hry Page 40 clause 13 (1), UGC Page 17, 9.1 (Ph.D.), 9.2 (M.Phil.), 9.3 (LLM/M.Tech)	As per UGC

The notification of Haryana govt. has deliberately skipped these recommendations of UGC. HRD Letter dated August 26, 2010 and UGC letter dated September 14, 201 and October 13, 2010 – Haryana Govt.
