The AIFUCTO has been working relentlessly for the University and college teachers of India over the formation of 7<sup>th</sup> pay review committee, the HRD Minister's approval to UGC decisions regarding amendment of UGC Regulations 2010 & PhD Regulations, 2009 & other urgent issues. But, most unfortunately, the present central government has shown no concern for the interest of lakhs of teachers across the country so far. The government remains indifferent and oblivious and as a result time has come when only our determined, committed and united movement can force the Government to mend its ways. Nothing is to be achieved without hard struggle.

It is in the same context and at the call of AIFUCTO, a meeting of Executive Committee (EC) of HFUCTO was held on 30-07-2015 at MDU Rohtak and it decided to participate in All India Federation of University and College Teachers' Organization (AIFUCTO) agitation on **7<sup>th</sup> August, 2015** by organizing Dharna and protest action from **12 Noon to 2 PM** in universities and colleges in the state of Haryana. It was further decided that all the universities and college units will send memorandum/ Demand charter to the concerned Deputy Commissioner/ SDM on that day. The main demands of University and College teachers of the country are also given below for your kind information.

1. Immediately constitute the 7<sup>th</sup> Pay Review Committee.
2. MHRD approval of UGC decisions of 3<sup>rd</sup> amendment of UGC Regulations - 2010 and PhD Regulations - 2009.
3. Minister - HRD appointment to AIFUCTO - FEDCUTA to discuss long standing professional demands.
4. Scrap API.
5. Roll back Choice Based Credit System and Central University at 2013.
6. Extend dates for Orientation Course & Refresher Course up to December 2015.
7. UGC pay scales for all categories of teachers.
8. Stop Commercialization of Higher Education.
9. Reject pension scheme – 2004.
10. Consult teachers' Organizations on Education Policies.

All the college units of HCTA are hereby strongly urged to participate in the protest with unity and vitality so that the Government can be strained to mend and accept the just demands of university and college teachers and the future of higher education is fortified. **A Dharna and protest action be organized in the college from 12 Noon to 2 PM on 7<sup>th</sup> August 2015 and subsequently the memorandum/ Demand charter be handed over to the concerned Deputy Commissioner/ SDM on the same day by all the units and its format can be downloaded from the HCTA web site [www.hcta.ac.in](http://www.hcta.ac.in)**
