We, the teachers of..... Affiliated to Haryana College Teachers Association request your goodself to resolve the following long pending issues relating to teaching employees working in 97 Govt. Aided Colleges in Haryana.

- 1. Benefits of Retirement, Gratuity and Death Gratuity' to the Govt. Aided College employees covered by new defined Contributory Pension Scheme (Known as NPS) appointed on or after 01/01/2006 is not implemented for the Govt. Aided College Employees. This file is pending with Finance Department till now.
- 2. Enhanced rate of monthly contribution of employees of Govt. Aided Colleges from 10% to 14% defined contributory pension scheme NPS. The Haryana Govt. Memo No. 2/47/2007-I Pension (FD) dated: Chandigarh, the 27/01/2022 already implemented for the Govt. Employees who were appointed on or after 01/01/2006 but this enhanced rate is not implemented for the Govt. Aided College Employees. This file is pending with Finance Department till now.
- 3. Revision of House Rent Allowance admissible to 97 Govt. Aided Colleges of Haryana, which has already been implemented for all Haryana Govt. Employees, Universities, Board, Corporation and all Govt. Aided Polytechnic Colleges in Haryana, w.e.f 01-08-2019 under 7<sup>th</sup> CPC but the employees of 97 Govt. Aided colleges are still getting H.R.A under 6<sup>th</sup> CPC and they have not been still able to get revised 7<sup>th</sup>.CPC H.R.A
