Dear Friends,

This is in continuation with earlier circular dated January 8, 2011. I am happy to inform you all that the final notification as per UGC Regulations 2010 is likely to come out soon. In this regard, we have met govt. officials several times and conveyed them our stand that we will not compromise UGC/HRD notification. I congratulate all the unit members for making January 7, 2011 Dharna at HEC office a big success. All the units are requested to remain ready for a statewide struggle to get UGC notification implemented in total in Haryana. In the final notification at the state level, we have to safeguard the interests of all sections of our teachers. On the one hand, advance and in service increments for higher education like M.Phil, Ph.D. etc have to be ensured, on the other, we are toiling hard to achieve all benefits recommended by UGC including enhancement in age of superannuation as per UGC/HRD recommendations. The issue of getting posts or designation of professor in colleges is quite vital for us. Another significant demand is a uniform API system in Haryana as the API system is going to be crucial for further promotions.

***We are happy to share with you that the vacant teaching posts up to 2007 are likely to be filled soon. This has been one of our most prominent demands at the govt level. HRA issue has been discussed with its solution within given govt. norms and rules suggested to the appropriate official/dealing.***

***The state convention of HCTA will be held at RK Sadan, Kurukshetra University, Kurukshetra on February 8, 2011. It will start at 10.a.m. Dr. Ram Prakash, member Rajya sabha, will inaugurate the convention and Dr. DDS Sandhu, VC KUK will preside over the seminar of the inaugural session. The theme of the seminar is : 'The Challenge Of Quality Education In the Public Funded Institutions of Haryana'. All the units are requested to participate in the convention with delegates and observers as per HCTA constitution. All are requested to deposit annual fee and clear all previous dues without any further delay. To deliberate upon the agenda of HCTA elections, report of the general secretary and finance secretary, an important meeting of central EC has been convened at Khalsa College, Karnal at 10 a.m. on Feb. 6, Sunday, 2011.
