A meeting of E.C. of HCTA was held on 28.1.12 at Vaish college, Rohtak and presided over by Dr. Rajbir Parasar. In the meeting Gen. Sec. presented a detailed report of events, since the last meeting at R.K.S.D. Kaithal. The members felt concerned about the committee constituted in the Higher Education Council, Haryana, which was chaired by C.M. Haryana” to review the practical aspect of 95 percent grant-in-aid scheme of the aided colleges of Haryana”. Regarding clarification on the issue of increments i.e advance or in-service, a letter from DGHE dated 27.2.12 has been issued which is a mere translation from English to Hindi and need more scrutiny, there is no mention of API relaxation in that letter.

The E.C of HCTA was strongly feeling that the presence of the students in the class room can be ensured by [a]pressing for the implementation of 75 percent attendance condition by the university and colleges administration.[b]by changing the syllabi of the U.G courses by involving the college teachers more and more.
